As already indicated in the Advertisement No.: DMRC/HR/Rectt./I/2019, dated: 14/12/2019, the vacancies were provisional & subject to increase / decrease. In the light of the outbreak of COVID-19, DMRC services were not running from 22/03/2020 – 06/09/2020, i.e., 169 days. There was also an overall reduction in the activities of DMRC. Consequently, the man-power requirements were reviewed, leading to reduction in the requirements, across various Departments. **It was, therefore, decided to reduce the number of vacancies for the post of Assistant CC / Contract (CNE06) from 03 to 02, as detailed below: -**
